Landlords, property owners, and agents must complete the attached direct deposit authorization form as a method of receiving their Housing Assistance Payments (HAP).

This method of payment not only eliminates the need to make a trip to the bank and the chance that a check will get lost in the mail, it is an easy way to receive the HAP quickly and safely. A remittance advice confirming the details of the deposit will still be sent through the mail.

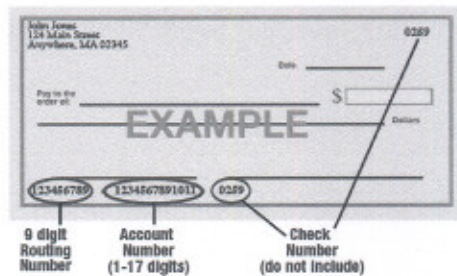
